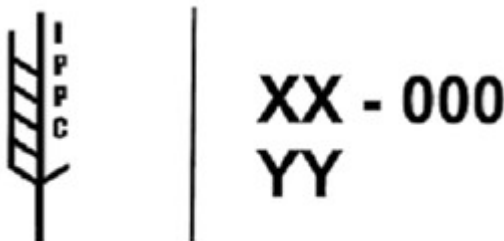

All Spare parts documents (Original Commercial Invoice, Packing List and AWB) must be clearly marked as **"SPARE PARTS IN TRANSIT"** & **"TREATMENT TC-7 REQUIRED"**

In case of wooden boxes/pallets/skids (even wooden frames in cardboard or plywood boxes), mandatory to have wooden parts stamped to meet International IPPC regulations in the wooden parts, as otherwise cargo MAY BE REJECTED by Environmental Authority, and we, ordered to ship it back.

Pls make sure your expeditors/forwarders do follow below procedures, order avoid possible problems with agri/customs Authorities in Brazil.

IT'S MANDATORY TO HAVE THE PROPER FUMIGATION CERTIFICATE ISSUED OR THE IPPC STAMP (SAMPLES AS BELOW ILLUSTRATED), OTHERWISE SHIPMENT WILL BE RETURNED TO ORIGIN.



XX represents the ISO country code.
000 represents the unique number assigned by the national plant protection organization.
YY represents either HT for heat treatment or MB for methyl bromide fumigation.

Below are samples of stamps on wooden pallets used in international shipping that indicate them to be in compliance to ISPM 15 rules.



IT'S ALSO MANDATORY INCLUDE BELOW INFORMATION ON AWB, BY CHOOSING WHICH ONE APPLIES:

- **Wooden Packing: Processed Wood;**
- **Wooden Packing: Treated and Certified;**
- **Wooden Packing: Not Applicable.**

- AWB: Original document must follow the consignment, same must include all above instructions marked. Airfreight to be pre-paid, otherwise same is not characterized in transit and local taxes apply;
- Commercial invoice: Original document duly signed/stamped must follow the consignment;
- Packing list: Original document must follow the consignment and also please include detailed weight/size for each item separated.

Copies of all documents, as soon as available (including AWB Draft) should be sent to us for checking prior to shipment.

Clearance and delivery time required.

For clearance at Airports require at least 2-3 working days.
Customs working hours MON-FRI 0900-1700HRS LT

CLOSEST INTERNATIONAL AIRPORT IS CURITIBA (IATA CODE CWB) .

***** IN CASE OF FLIGHT RESTRICTIONS TO CWB -EITHER DUE TO THE TOTAL VALUE OF THE SPARE PARTS OR THEIR ORIGIN-PLEASE CONSIDER GRU AIRPORT (GUARULHOS) AS AN ALTERNATIVE. IT IS LOCATED APPROXIMATELY 500 KM FROM PARANAGUA, BUT IT IS A BIGGER AIRPORT WITH MORE FLIGHT OPTIONS.**

RMK.: WE STRONGLY SUGGEST YOU NOT TO SEND SPARE PARTS THRU COURIERS, AS IT MIGHT BE SEIZED BY BRAZILIAN CUSTOMS OR HAVE IMPORT DUTY/TAXES APPLIED OF APPROX 90% OF INVOICE VALUE AS WELL AS UNNECESSARY CUSTOMS CLEARANCE DELAYS.

REMARK:

Couriers in Brazil are not allowed to transport any kind of goods in transit (like these span gases to the vessel) but only printed material, books, Nautical

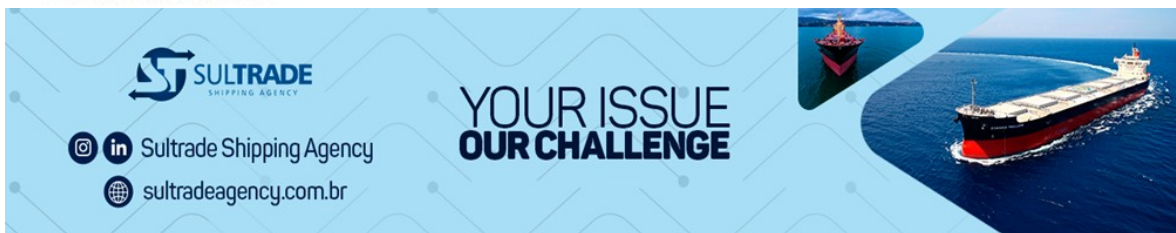
publications, etc.. And when they accept abroad any other kind of material, this is
aced by Brazilian Customs, as an import (subject to import duties, state taxes, etc..
including courier's clearance costs at their hub airport in Brazil).

The value of taxes/charges are about 100% of value declared. Main problem is that
sometimes, courier quite a long time to clear it through their Customs station at
their incoming hub airport. This clearance at Customs is done by the courier
themselves.
