Good day.

Yours below is duly noted. Please find below instructions for crew change at **Angra dos Reis**:

Travelling document recognized by Brazil is only the Passports (which has to be valid for at least 6 more months of the traveler's first entry to Brazil). SBooks and SIDs are only good to prove a seafarer/s working condition, and that he is either entering or departing the country in connection to a vessel, at a certain port.

Crew from signatory countries of ILO C-108 that maintain agreements with Brazil for VISA exemption (case of LITHUANIA, UKRAINE, amongst others) will be required Passport and the SBook to access the country (for a period of 90 days).

Furthermore, kindly note hereunder documents which will be requested to embark/disembark at **Porto do Açu**:

EMBARKING:

- Passport, SID (if available) and Seaman's book;
- Flights tickets;

DISEMBARKING:

- Passport, SID (if available) and Seaman's book;
- Flights tickets;

Please note that the nearest airport is Aeroporto Internacional do Rio de Janeiro - Antonio Carlos Jobim (GALEÃO) - (IATA: GIG). For on-signers flight arrangements, we suggest arranging flights with at least 3 hours between international and domestic flight so that they have sufficient time for Immigration procedures and avoid any problems upon arrival in Brazil.

REMARKS:

- 1 - Transit Time from GIG airport to Rio de Janeiro port
Working hours - 03:30h
Weekend / Evening - 02:30h
- 2 - Time limit for the joiners to arrive and embark at the same date is 1700HRS LT
- 3 - Crew Change is allowed only at inner Anchorage (For outer anchorage a special request must be made)
- 4 - Port Authorities works from Mon/Mon - 07:00AM up to 07:00PM
- 5 - Weekend is allowed for crew change

It is important to highlight that each Brazilian port has its own interpretation on the Health Authority rules in force, meaning that all above instructions can be changed anytime without any pre advise. Sultrade is aware to keep you posted immediately in case of any further changes on the above instructions.

Please confirm the launch boat is designed for transporting persons / crew to and from offshore facilities, offering good stability and speed, manned by at least 2 persons (skipper + 1), equipped with seating and LSA equipment.
