According to the malaria treatment protocol, the cure verification slides, under the responsibility of the municipal epidemiological surveillance, should be conducted on days 3, 7, 14, 21, and 42 after the treatment initiation for Plasmodium falciparum. In the case of foreign patients, they will be discharged (if in good and stable condition) upon receiving a

negative result and should return to their country of origin to continue treatment following the protocols of their respective countries, as there is a risk of retesting positive during the following two months .

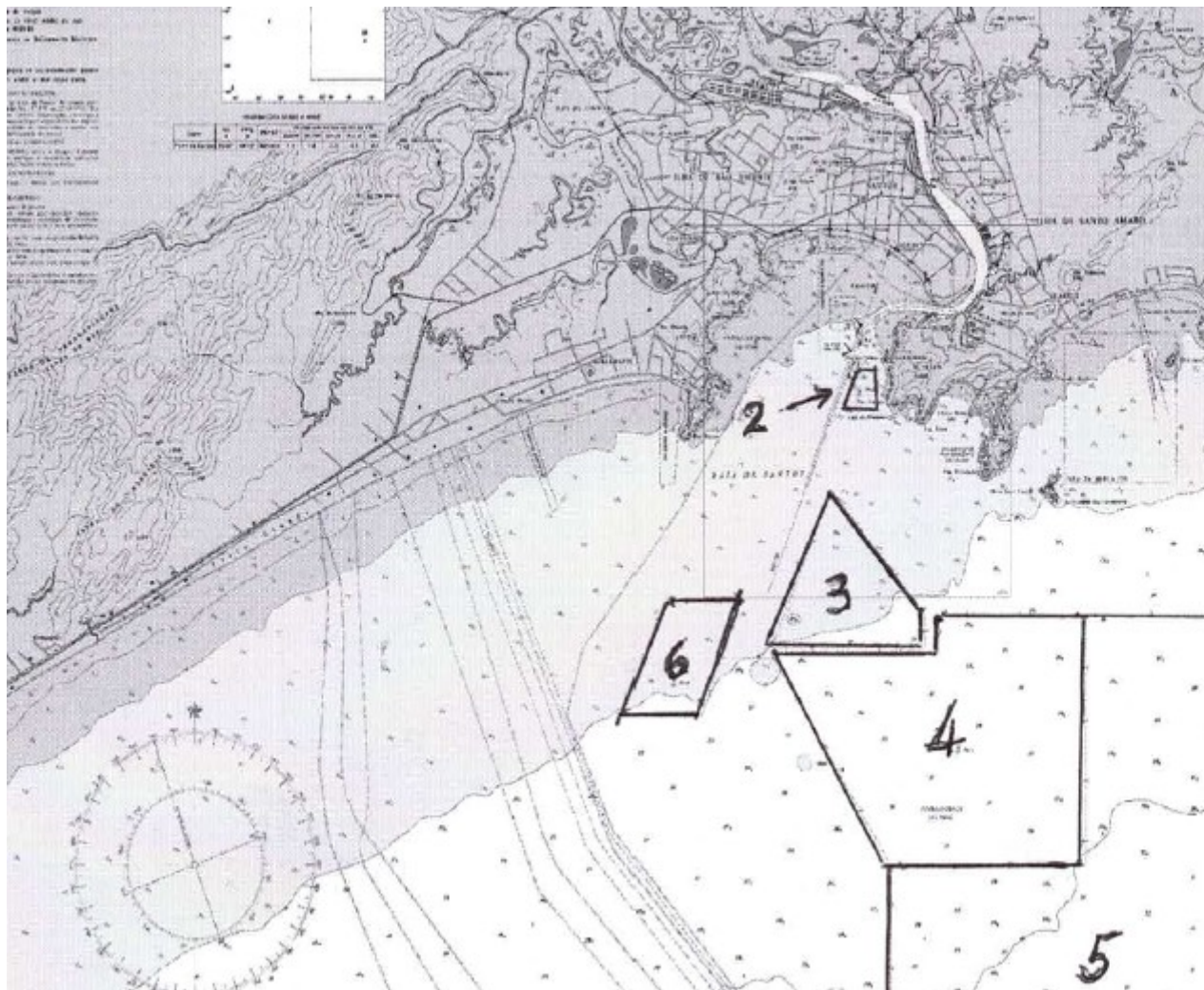
