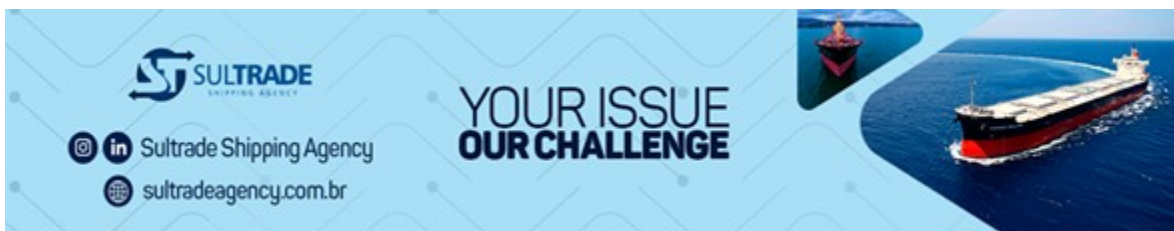

Good day!

Yours below is well rcvd/noted and thank you for your call.

That's right, Itaqui PDA is abt USD 12,200 and UTM (Ultra Thickness Measurement) is already included based on expected costs as per Messrs. End Zaya offer and subject to alterations under their terms/conditions, if needed.

Regarding its obligation, we confirm that UTM must be carried out together with DPC inspection. Navy DPC establishes on their rule NORMAM 203, that any bulker aged 18+ years (counting as from keel laid date, and understood that yours CORAL ISLAND had her keel laid on 2006), prior loading any ore cargo (whose SG is higher than 1,78 t/m3) has to compulsorily be subject to a condition survey carried-out by a Class Society (rather than the one classifying the vessel) recognized by Brazilian Navy, and during such inspection plate's thickness of vessel to be tested by a USTM expert.

The agent must request such survey in advance to DPC, and vessel's holds are to be empty and ready for inspection. Normally said inspection on board the vessel lasts some 8 or 10 hrs (including thickness measurements of approx. 30% of vessel's plating) and validity of the certificate issued is of a year.

According to the Navy Rule (NORMAM 203) these services must be requested at least 48 hrs in advance, so just to anticipate procedures, pls note that copies of following documents will be required prior to inspection takes place:

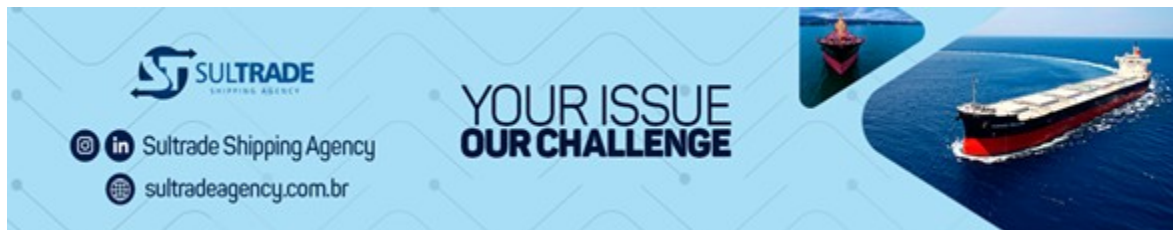

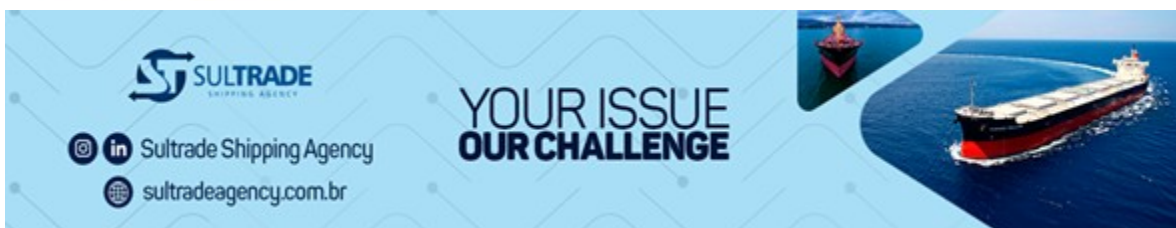
Meanwhile, we are checking DPC costs and availability and will revert to you within today as requested.
