Dear Areti Kritikou, good day!

Yours duly noted, we'll be glad to attend you. Kindly find below regulations to embark/disembark at Santos port and also pls find attached our PDA considering crew change 040N/S x 040FF/S.

- 1. Travelling document recognized by Brazil is only the Passports (which has to be valid for at least 6 more moths of the traveler's first entry to Brazil). SBooks and SIDs are only good to prove a seafarer's working condition, and that he is either entering or departing the country in connection to a vessel at a certain port.
- 2. Crew from signatory countries of ILO C-185 that maintain agreements with Brazil for VISA exemption (case of RUSSIA, BOSNIA, CROATIA, FRANCE, GEORGIA, HUNGARY, MOLDOVA, MONTENEGRO, SPAIN, THE PHILIPPINES, amongst others), will be required Passport and the SID to access the country (for a period of 180 days). In case these Nationals are not in possession of SID, the S.Book will be required and only a 90 days stay will be granted.

## EMBARKING:

- Copy of valid Passport, SID and valid Seaman's book;
- Flight e-ticket;

## DISEMBARKING:

- Copy of Passport, SID and Seaman's book;
- Flight e-ticket;

Nearest Airport : GRU (GUARULHOS / SÃO PAULO BRAZIL). Which is around  $160 \, \text{KM}$  fm Santos, normally, transit time is  $2 \, \text{hrs}$  or  $5 \, \text{hrs}$  on heavy traffic.

For on-signers flight arrangements, we suggest to arrange flights with at least 3 hours between international and domestic flight, in order to on-signers have sufficient time for Immigration procedures and avoid any problems upon arrival in Brazil.

Crew Changes at Santos port are allowed only at BERTH (crew change are NOT allowed at anchorage area).

Fyinfo only, note that the port entry permission can only be applied after vessel's berthing, from 8am to 9pm.

If vessel delays her berthing, no outer roads permission is granted by the port authorities, strictly due to safety reasons
