Dear Ms. Angelika Pitsinou,

Good day!

We acknowledge safe receipt of your message.

Fyg, we're experiencing many problems in arranging SSCEC renewals at Santos, as local Sanitary Authority is implementing a project at the port (which is currently in force), where all applications must be requested through the system, and at a certain advance. So, for the SSCEC at Santos, we'd like to draw your attention to the following:

- 1. All applications for SSCEC renewal at SANTOS must be done through the PSP system (Port Paperless System) before vessel's berthing and a week in advance. So, every Monday, Sanitary Authority will start their schedule for inspections of the next week; 2. The Agent must insert to the system, the exact day and period (morning or afternoon) in which the inspection is required/expected to be executed, according to Sanitary Authority availability and considering only working days (FYG, Sanitary Authority at Santos does NOT work on Holydays and Weekends). After application being submitted thru the system, Sanitary Authority will confirm availability (or not) to attend. Case they have availability for the selected day/period, they will also confirm it on the system. So, at selected date/period, Sanitary Authority will analyze the process and will decide whether they will board vessel for physical inspection or will just remotely analyze documents produced by the vessel;
- 3. Just for the sake of good order, Sanitary Authority will only analyze the process on the select date, provided that payment of renewal tax is already affected by the agent. Case vessel is not berthed at the date/time scheduled, they will simply refuse to renew the SSCEC;
- 4. If the vessel berths and departs out of selected date and/or out of Sanitary Authority working time, it will not be possible to arrange the renewal at Santos.

Based on above, SSCEC will SSCEC renewal will be subjected to Sanitary Authority at Santos. Furthermore, please note that it will be necessary to pay in advance the SSCEC tax (once paid, said tax will not be reimbursed), in order to apply for SSCEC renewal

through the system and select a date/period for the Sanitary Authority to analyze the process.

It's important to highlight that each Brazilian port has its own procedures for SSCEC renewal, meaning that all above instructions/procedures can be changed anytime without any pre advise. Sultrade is always following up their news to keep you posted immediately in case of any further changes to the above.

Please find attached involved costs for renewal of SSCEC at Santos. Just for the sake of good order, in case vessel berths at Left Margin Terminal, boat to access Terminal will be necessary. Also, in case vessel is expected to berth at TIPLAM Terminal or USIMINAS Terminal, transportation cost will increase.
