Good day!

Further to our last, pls note that according to our latest conversation with Bunker One, bunker supplier representative, they can attend the vessel upon un-berthing on November 08th at anchorage subject to weather/sea conditions.

Moreover, pls be advised that proper formalities for a bunker call only at Itaquí anchorage shall be done within Brazilian Systems (Marine Merchant System and Paperless port system) in order to proceed with bunker supply by STS there.

This procedure is needed as vessel is calling Itaquí port for discharging and Customs Authority requires that call formalities for bunker to be done separately.

T'fore, an outward clearance will be necessary to complete her sailing procedures and in case her next call is in a foreign port, Immigration outward tax payment will be necessary. Otherwise, case her next port is confirmed to be in Brazil, this tax payment shall not be necessary.

Based on the abv, please find attached our PDA with all involved costs for the procedures/clearances above mentioned. Should you have any questions, feel free to reach out.

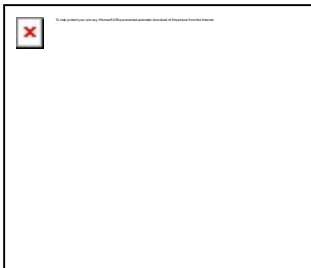

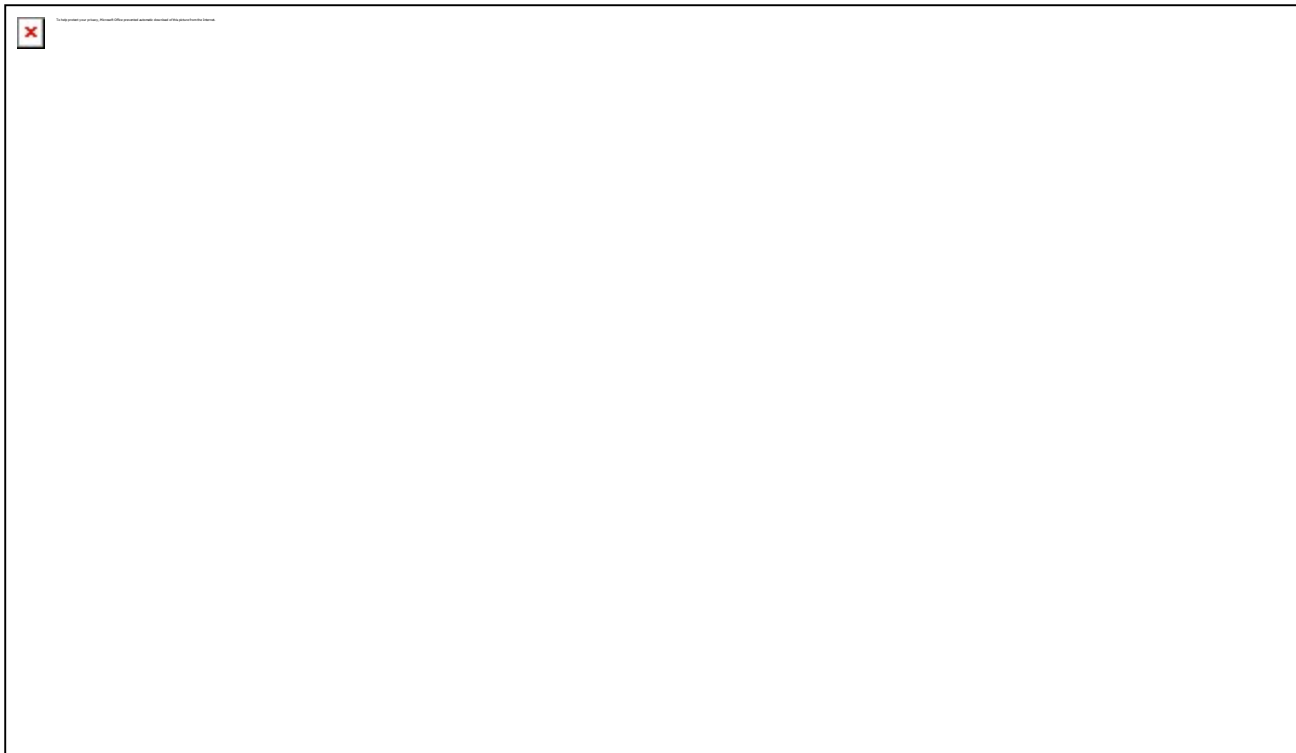
