In addition to ours below, please note that attached certificate will not be accepted by Sanitary authority and she will not receive FP on arrival.

Pls note that Sanitary inspection tax must be paid in advance through Brazilian Paperless Port System in order to schedule the inspection. For your reference, only after payment done, available dates for inspection are made available and scheduling is possible. T'fore, the sooner confirmation is provided and tax paid, the better.

Important to note that inspection date availability is subject to Sanitary authority current inspection schedule and in case they have other vessels to attend ahead of her, inspection may be set to the forthcoming days after her arrival and not in the first workday (Monday) after her arrival (Sunday).

Good day!

Further to our last message, as she's arriving with only one SSCEC issued at a non-WHO-recognized port, kindly find below two scenarios for SSCEC renewal at Salvador port.

As she's expected to berth upon arrival (Nov 2nd, 01:00 AM), we understand that she'll remain idle alongside, awaiting the Sanitary Officers' inspection schedule, which is only available on weekday mornings. Until the inspection is completed, vessel won't receive Free Pratique nor be allowed to operate until SSCEC is renewed by Sanitary Authority. Nevertheless, as charterer's agents are the ones responsible for vessel clearances/procedures for Salvador call, important to double check directly with them regarding this matter.

T'fore, please find attached a PDA for the inspection alongside Cotegipe Terminal, should this option be agreed/confirmed with the Charterers' Agents.

Alternatively, vessel may be shifted to Area 3 anchorage prior to berthing. However, this option will involve additional expenses such as pilotage, watchmen (per 12-hour shift), and launch boat services. The purpose of this alternative is to avoid vessel to remain idle alongside.

**Important to point out:** Sanitary Officers only performs SSCEC inspection on morning time of weekdays. Also, USD 922.26 is the total amount for the sanitary inspection alongside, considering that no other service will be required by Sanitary Authorities whilst inspecting, such as garbage disposal/pest control certificate renewal. In case boarding officer detects the necessity of those services, we will provide and add the costs into the final amount.
