Our intention is to have all 3 on-signers embarking directly upon the vessel's arrival / berthing, so we will be bringing them to Manaus before the vessel's ETA.

Moreover, the off-signing 3/O shall disembark a few hours after the embarkation of the on-signers, as only a limited time of handover would be required.

On the contrary, the off-signing Master shall disembark after the discharging operation completion, as late as possible before the vessel's departure, to accommodate maximum handover time.

A more detailed embarkation – disembarkation will be provided once their flights are in place.

General instructions:

Crewing Operator

- * Usage of public transport such as shared cars / minivans, buses, or trains, is encouraged whenever possible. Usage of taxis shall be minimized whenever possible. Optimal and cost-effective transportation organization is expected from the agents.
- * In case of flights arriving / departing around the same time, the crew shall be required to wait at the airports. No single transfers to be arranged unless of long interval times.
- * Hotel accommodation shall be avoided, but, if necessary, to be arranged in 2-3*** hotels. Officers can be accommodated in single rooms, Ratings should be combined in double rooms.
- * Combining launch boats for crew changes with stores, technicians, provision etc. deliveries is required.
- * We would highly appreciate the assistance of the local agents to secure optimum means of transportation at most competitive prices and provide the solutions how to minimize the costs locally.
- * In case of any last-minute changes pertaining the requirements/regulations of local Immigration, Health Authorities and/or any other Government Body that may affect/delay/disrupt the planed crew change at the designated port of call, kindly inform immediately the responsible Crewing Superintendent by phone & email.
