
Message well received. Based on Port line up and current scenario, we understand that most probably vessel will have to wait some days at Santos anchorage prior berthing.

Furthermore, regarding your below questioning, usually for vessels that will load Corn at SANTOS port, Holds Pre-Inspection at anchorage is performed prior berthing. So, in case you wish, please note that we may appoint an independent surveyor to follow up Holds Inspection at berth (Official Inspection at berth, or Holds Pre-Inspection at anchorage if any) with Charterers/Shippers surveyors on behalf of Owners. If confirmed and our surveyor must follow up Holds Pre-Inspection at anchorage, normally half of boat service has to be considered, as we may have it shared with Charterers/Shippers surveyors, plus the cost of surveyor and clearances.

Fyg, kindly be informed that our Operations Team has included a dedicated Surveyor, responsible for conducting daily remote guidance of the vessel's holds preparation for loading operations, in accordance with standard methods in each

Brazilian port. This service may take place during navigation and while the crew is preparing the holds ahead of the pre-holds inspection at anchorage and/or the official holds inspection upon berthing. So, based on daily photo records to be sent by Master to ours emails (operations@sultradeagency.com; surveyor@sultradeagency.com), Sultrade's Surveyor may provide technical feedback and point out any critical issues to be addressed prior to inspections (pre-holds inspection at anchorage and/or the official holds inspection upon berthing).

Just for the sake of good order, grain loading standards means that CH Inspectors normally expect to find vessel's holds in good clean condition to meet mentioned standards thus shell plates, bulk-heads, frames and pipe-gards, tank-tops must be clean, dry, odorless, free of rust, loose flakes and any residues of previous cargoes and/or any contaminants to the grain cargo. Normally visual inspection will be done as well as white gloves test, meaning that surveyors will be scrubbing plates with a working glove or a white cloth, at random points, to verify that no dirt/dust/residues comes off.




Above photo depicts a very common kind of residues found behind holds frames (even after first washing) after a cargo of coal and/or fertilizers. The above causes rejection of holds. Fertilizer cargoes will also leave stuck residues on the frames, pipe guards or ladders as well.


At Santos, Charterers/Shippers normally carry-out a pre-inspection at anchorage right after vessel's arrival to be sure they'll face no problems by the time vessel comes alongside and is subject to the official inspection. Not always, but in some cases, they also do request the hose test to verify water tightness of hatch-covers. In this case, Master is to verify all hatch-covers fitting rubber gaskets to check whether they are holding tight and water is not penetrating the holds, as this will also reprove holds' readiness for loading.

Crew to perform a "white glove test" specially at the hopper tanks plating (top and bottom) where coal and fertilizer dust as well as washing residues normally accumulate, behind the brackets/frames and also pipe guards as these are the places where most commonly surveyors will find residues stuck to the plating. Also check well the corrugated plating at bulk-heads. Make sure that tank tops at holds bottoms do not present any loose flakes, as scaling rust causes rejection of

holds for meals' loading (remember that surveyors may use scrappers or spatulas to try to loose scales). Take special attention to those areas where no new painting has been done to make sure that old paint is not flaking or coming out loose, as this will also cause rejection of holds. Cargoes of coal and coke generally leave dark stains on holds' plating that hardly come off when rinsing, if that's the case, and if stains were not removed by hydro-jet and if necessary scrubbing has to be done, pls ask crew to pay attention to remove it, as surveyors may reject holds on account of any stains that are coming-off on glove test.



Above and below photos show status of frames and plating that will cause Inspectors to reject the holds.



Also, important to check whether any existing stains are not coming-off to the white cloth when rubbing it against the plate. If the stains are coming-off, the surveyors will most certainly, reject the holds, as these stains are considered contaminants. Important is to have the stain washed out, and painted over (if that to be the case - touch painting will solve the problem in most cases).

Good day!

After checking locally, kindly be informed that MV STAR FAIRFIELD has not yet been included to SANTOS Port Line up and so far we don't have confirmation about which Terminal this vessel will berth/operate.

Fyg, cost for Fresh Water supply at Santos will be subjected to which Terminal the vessel berth. So, in case vessel berths in a public berth (Commercial Quay), FW supply can be done by shore connection at a cost of approx. USD 5.38 (per MT). Please note, however, that if vessel berths in another Terminal for the loading operation, FW supply will have to be done by Barge and costs will increase, approx. USD 21.00 per MT (cost TBC /Min. 100MT), plus approx. USD260.00 for the FW certificate.

Referring to details of supply at Santos, please find attached our message for the previous call at Santos port.

We'll be monitoring the Port line up, in order to revert with vessel's waiting time at Santos anchorage and exact cost for FW supply.
