Hi Capt De Castro - Given your vessel current cargo is steels and that crew already managed to do some works on the upper areas of the holds during laden passage, it shouldn't take the crew more than 2 days max to prep the holds for grain loading. Furthermore, the next loadport is basically a neighboring port and judging from charterer's agents last update, seems that there's no congestion in Barcarena and that vessel can berth on arrival. In this instance, we would like to reduce the waiting time for hold cleaning as the cost to offhire the vessel for hold cleaning is high. Hence so please do keep hold cleaning ops / duration to a minimum.

Hence upon completion discharge, departure and drop pilot at Mosquero P/S, please redeliver your vessel from Chinaland and find a safe spot outside P/S, away from traffic to anchor for hold cleaning. Upon completion hold cleaning, only then we deliver vessel to Oldendorff.

Replying on your separate message, for ETA wise, please declare 25th Nov (this is basis latest update ETD 23rd with add-on 2 days for hold cleaning). We can monitor again in upcoming days and amend the ETA if needed.

Dear Sultrade team RIC - In view of vessel calling Barcarena for loading grain cargo, we would like to appoint your team as OPA to protect our interest with the upcoming hold inspection on the understanding that it would be a strict cleanliness policy to load grains in Brazil. Please render your assistance and advice master accordingly. As per usual we will arrange agency appointment via HarborLab for your PDA upload. Thanks.
