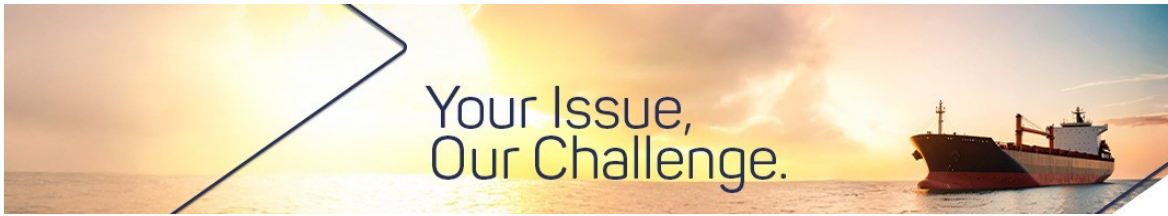

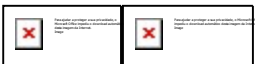

Yours below is duly noted. Please find below instructions for crew change at **Porto do Açu**:

1. Travelling document recognized by Brazil is only the Passports (which has to be valid for at least 6 more months of the traveler's first entry to Brazil). SBooks and SIDs are only good to prove a seafarer/s working condition, and that he is either entering or departing the country in connection to a vessel, at a certain port.
2. Crew from signatory countries of ILO C-185 that maintain agreements with Brazil for VISA exemption (case of BOSNIA, CROATIA, FRANCE, GEORGIA, HUNGARY, MOLDOVA, MONTENEGRO, SPAIN, **THE PHILIPPINES**, amongst others), will be required Passport and the SID to access the country (for a period of 180 days). **In case these Nationals are not in possession of SID, the SBook will be required and only a 90 days stay will be granted.**

Furthermore, kindly note hereunder documents which will be requested to embark/disembark at **Porto do Açu**:

EMBARKING:

- Passport, SID (if available) and Seaman's book;
- Flights tickets;

DISEMBARKING:

- Passport, SID (if available) and Seaman's book;
- Flights tickets;

Please note that the nearest airport is **Aeroporto Internacional do Rio de Janeiro - Antonio Carlos Jobim (GALEÃO) - (IATA: GIG)**

REMARKS:

- Crew change allowed only with daylight.
- Transit Time from GIG airport to Porto do Açu:
Working hours - 06:00h
Weekend - 05:00h
- Crew Change is NOT allowed at Anchorage
- Port Authorities works from Mon/Fry - 09:00AM up to 04:00PM .
- During the weekend we can embark the joiners but no Disembark is allowed due to the lack of Customs to inspect the luggage.
- Disembark at Acu is made 02 times per day according the time of Customs inspection which is 11:00AM and 03:00PM and is not allowed during the weekend.
- If the vessel arrives and leaves during the weekend we need in advance (at least 2 days) to request a special clearance to disembark the crew which can be authorized or not by Custom Officer.
- Boat is not necessary for embark or disembark.

It is important to highlight that each Brazilian port has its own interpretation of the Health Authority rules currently in force. Therefore, all the above instructions are subject to change at any time without prior notice.

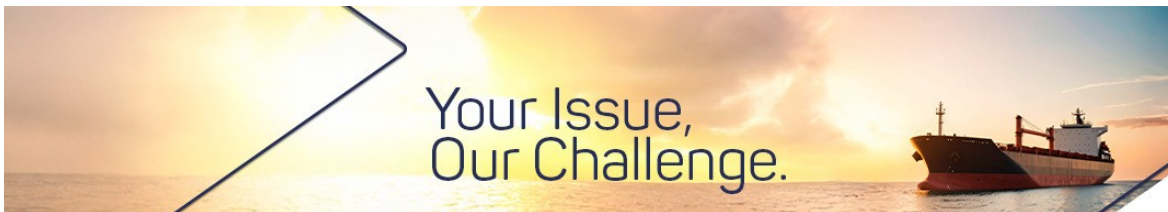

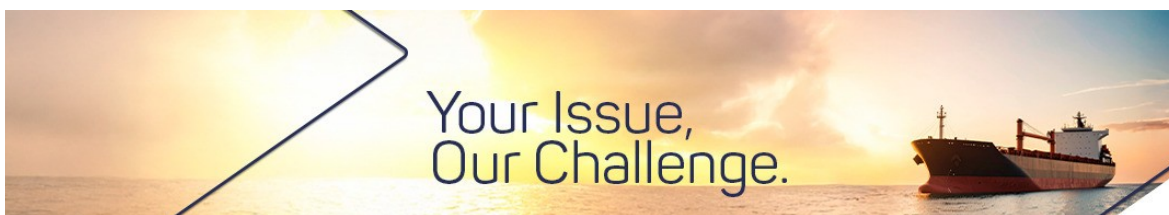
