Foi constatado através de monitoramento via "AIS", que a embarcação encontrava-se em situação de fundeio em local proibido fundeadouros estabelecido na Carta Náutica nº 1711/DHN e 23200 DHN, e ou alínea k) do item 4.1 Capítulo 4 da Normas e Pr Para a Capitania dos Portos de São Paulo (NPCP-SP), nas posições Latitude 24° 05' 47.135" S e Longitude 046° 09' 43.547" W. ocorrência 27/08/2025.

Defesa sem amparo legal. A poligonal do Porto de Santos possui outros fundeadouros, além do 4 e 5, onde está autorizado o fur embarcações. Defesa indeferida.
