Yours below is duly noted, and will be a pleasure to assist you on your request. Please be advised that couriers in Brazil may be used only for printed materials, including books, manuals, and publications, as well as non-commercial samples and documents, as these items are non-taxable.

Couriers are not authorized to handle customs bonded transits. Therefore, any items other than those mentioned above, when shipped via courier, will be taxed by Customs as imported goods (approximately 100% of the value declared on the Commercial Invoice) and will be compulsorily cleared at the courier's hub airport (most of them via Viracopos Airport – VCP, in São Paulo state). In such cases, it is not possible to calculate or determine the clearance timeframe.
