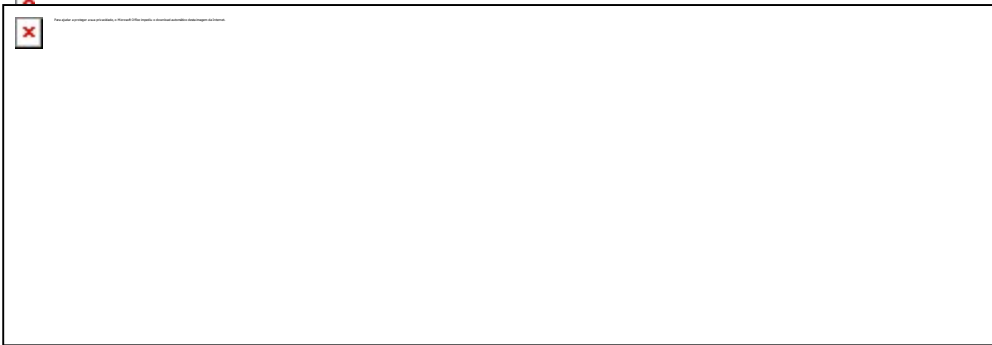

Thank you for your message below.

**IMPORTANT INSTRUCTION FOR COURIER DISPATCH:**

Couriers in Brazil may be used for printed material including books, manuals and publications, non-commercial samples, documents, as these items are non-taxable. Couriers are not authorized to handle Customs bonded transits, and therefore anything else rather than before mentioned items, when shipped by couriers will be taxed by Customs as an imported item (on approx. 100% of value declared on the COMMERCIAL INVOICE) and will have to be compulsorily cleared at the courier's hub airport most of them use the airport of VCP at Sao Paulo), and it is not possible to calculate or determine their clearing time. Depending on the shipped item, like electronics including peripheral stuff even scandisks, pen-drives or DVDs, these may even be seized by Customs.

Please note that the vessel is not announced in the Paranaguá Port System, thus we are unable to provide you with a prospect now.

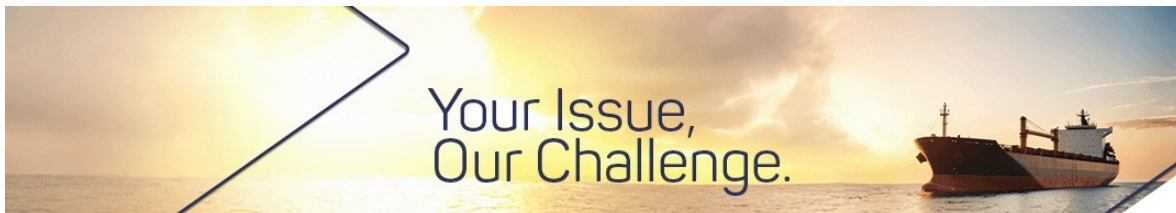

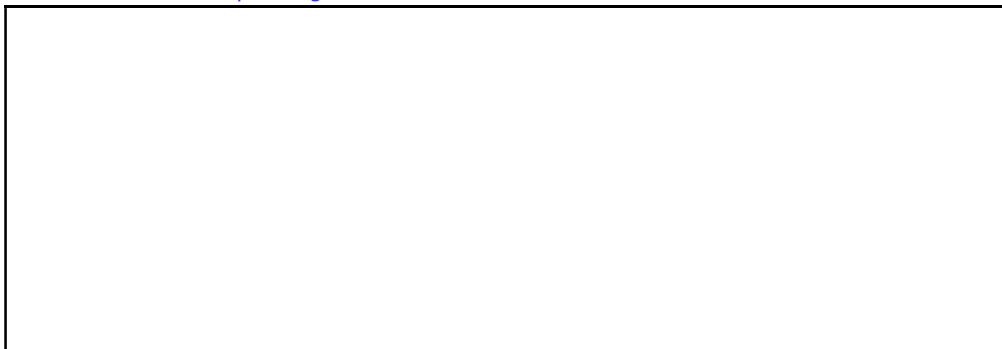
