- At Itaguaí Port (formerly Sepetiba Port), the Health Authority schedules SSCEC renewals only on Mondays and requires one week's prior notice.
- We can proceed with the payment of the SSCEC renewal fee, however, please note that this fee is non-refundable. In case the vessel's schedule falls on a weekend or outside the Health Authority's working hours, or if there are any changes after the renewal has been booked, it will not be possible to proceed with the service.
